<u>District of Columbia:</u> OCTO does not take any special measures to tag pdf files beyond what is automatically done by Acrobat. We make every effort to be 508 compliant, however we do allow scanned image pdfs, such as those on the CFO site, to be published even though accessibility tools cannot read them. Maine: Maine Revenue Services does not utilize tagged PDFs. Our agency is set up so that we have one web site coordinator and multiple content managers. The coordinator is responsible for administering the overall design of the site and ensuring that State and ADA web standards are met. The content managers are, essentially, responsible for updating the web pages (including PDFs) that pertain to their specific area (tax division). I have listed my contact information at the end of this email. Minnesota: Minnesota uses a Content Management System (CMS) called Stellent. The product essentially converts documents into PDF format unless the set up specifically precludes this conversion. Therefore, most of the documentation available in terms of forms, instructions, fact sheets, etc. are available in the Adobe PDF format. I am forwarding a copy of this message to Lynn Andrews, who coordinates the publication of fill-in and printable forms and instructions, because she works in our Communications Division (the owners of Stellent). Hopefully, she or her collegues can answer the remaining questions for you.

<u>Mississippi:</u> The State Of Mississippi does not support/use tagged PDF files. Our PDF files are not Section 508 compliant.

Missouri: At this time, Missouri's files are not tagged. It is something we are looking into. Along with the
