MESSAGE FROM CANADIAN FUEL TAX COUNCIL (FTC) <u>RICK CALLAWAY</u>

Happy New Year to everyone and hope the best for 2012. The Fuel Tax Council (FTC) held its last semi-annual meetings in Ottawa, Ontario on September 28 and 29, 2011. The next meeting will be Quebec City, Quebec on May 15 and 16, 2012.

The FTC's recent accomplishments and current priorities are in four main areas. These areas and the current priorities are:

1. Audits and Enforcement

A project team continues to work on a framework for drafting and maintaining a System's Information Binder to be developed for each fuel tax collector. The binder will document a collector's systems and will be used by any jurisdictions' auditors to reduce effort and increase accuracy during the course of a fuel tax audit. The project team has developed a number of key components of the framework including the scope, contents and format of the binder, as well as, the governance process to ensure approvals and controls are in place. The project team is currently expanding its consultation process and planning for preparation of the first binder.

Other priorities in the area of audit and enforcement include the development of Best

Practices for fuel tax audits providing a framework of objectives, procedures, documentation standards and context for jurisdictions evaluating or enhancing their audit programs. An Enforcement Binder to identify and document the various types of "below the rack" evasion with proven practices to detect, audit and enforce compliance. The FTA is working with the federal government to improve information sharing concerning fuel imports and exports, as well as, with industry on analyzing unverified inventory losses allowed with the goal of ensuring the losses and methods of delivering them are as fair and equitable as possible.

2. Communications

The FTC continues to convert and update its Fuel Tax Guide from paper to electronic form. The Guide provides a catalogue of current tax rates, exemptions, refunds, licensing requirements and other elements of Canadian tax programs by jurisdiction in a comparative table format.

The FTC website is being updated and re-formatted to offer public and secured communication to more devices. Expanding industry participation at the semi-annual meetings is being explored to respond to greater demand for involvement while effectively maintaining and achieving the objectives and mandate of the FTC. The By-Laws are being reviewed to introduce a number of important changes to the operation of the FTC including the extension of terms for its officers and changes to the meeting format to increase

participation and provide effective leadership.

3. Uniform Reporting

The FTC continues to enhance fuel tax reporting through examination of its generic fuel tax return for handling emerging accountable products and changing jurisdictional requirements. An initiative between governments and industry is underway to ensure that data elements and the level of detail being reported are appropriate given legislative requirements and collectors' systems. Electronic reporting standards are also being updated as jurisdictions implement or plan for electronic filing or information exchanges.

4. Training

The last training session was in November 2011 in Vancouver, B.C. and offered a combination of two courses for the first time. This was intended to provide customized training to a more targeted group. The next raining will be in May 2012 in Halifax, Nova Scotia and offer the Fuel Tax Audit program. All of the training materials and exercises for the three traditional courses are being reviewed and updated with a longer-term training plan under development for approval at the next semi-annual meeting.

I have been in the role of FTC Manager now for four months and have experienced a number of interesting and challenging situations and have had the opportunity to meet and work alongside many knowledgeable and energetic people. The opportunity to meet with and exchange ideas and

The FTA Motor Fuel Tax Section Uniformity Committee met at the Embassy Suites, Charleston, West Virginia on September 17, 2011. Sharon Gostovich (WY) Uniformity State Chair called the meeting to order. Thirty-four (34) were in attendance.

<u>Minutes</u>

The minutes of the April 2011 Uniformity Committee in Oklahoma City, Oklahoma was approved.

Presentation

Rick Evans with Intellifuel gave a presentation on Electronic Fuel Movement System.

Scott Louie with Chevron gave a presentation on prior period transactions.

SUBCOMMITTE REPORTS

The <u>Compliance Subcommittee</u> Jeremy Neeck (MN) reported there were twenty-four (24) in attendance. The Committee discussed:

Training Schedule for 2012 – FTA is starting the planning on training for 2012.

Dyed Diesel Stats – The dyed fuel final statistics for 2010 along with first quarter and second

quarter for 2011 were reviewed. The committee wants everyone to review their results for their State.

IRS Update – It was reported that ethanol credits will probably expire at the end of the year and Congress is trying to extend the biodiesel blenders credit and offer a credit for blender pumps at the retail stations.

Old Projects

Expanding the dyed fuel states report – the committee will be looking at adding type of vehicle and industry to this report

Scanned documents v original and their laws – States didn't want to commit to one way or another, the committee decided to let each state handle this situation independently.

Airport "stale" fuel issued and taxation – it was suggested that the committee look at a case that happened at Miami Airport and find the results of that case and share it with the group at the next meeting.

Sale of "off spec" military fuel – the committee discussed how the DMRS handles this for the military and it was suggested we table this until next meeting so we could get more information.

New Projects

Open discussion on: •MT request if any state is using a canned system for Dyed Fuel Enforcement tracking.

Best Practices for "Virtual

Audits" – white paper has been completed and approved by the full committee.

The Forms Management Subcommittee

Lee Gonzalez (Florida) reported that this committee met with Electronic Commerce. There were thirty-four (34) in attendance with three (3) by phone. The subcommittee discussed:

Crosswalk (FTA and STCC

Codes) – The team had a difficult time identifying reportable products from the STCC code list. The committee wants to talk with the National Railroad Association and ask for their assistance.

Renewable Fuels – The team reviewed existing schedule and product code structures and determined that the existing structures may not be robust enough to capture the number and diversity of future codes. The Tier system was introduced for discussion.

New Jersey Forms Review -

The team reviewed SMF-10, including schedules and has identified areas that are not uniform and will contact NJ with their recommendations.

Terminal Operator (Gross Gallons) – It appears fuel arriving by rail and truck to a terminal may be in gross gallons. It was suggested to survey the terminal operators to identify scenarios where gross gallons might be used.

Product Codes Request – A request was made for additional

product codes. The purpose of the request was two fold, first it was felt it would benefit taxing jurisdictions if they captured product codes at a more granular level and second, concern was expressed that product codes that are being used by industry but not recognized as a uniform product code of FTA.

The <u>Electronic Commerce</u> <u>Subcommittee</u>

Hal Lovell (California) reported there were ten (10) in attendance with one (1) by phone. The subcommittee discussed the following:

Impact of product code issues on EDI – Expansion of the product code may mean a new EDI version. The committee will continue to monitor this item.

Import/Export Data Exchange -

It was discussed instead of using the standard flat file format many States are provided Excel filing. Excel provide sample files and a standard format be developed and encourage. The committee needs to start discussing an XML version.

The <u>Communication and</u> Coordination Subcommittee

Christy Dixon (OK) reported that twenty-four (24) were in attendance. The subcommittee discussed the following and the September Uniformer was passed out.

The Taxation-Diversion-Alternative Fuels Booklet – Has been completed and published.

Native American Survey Update Booklet – has been completed and published.

MOU update – The draft MOU was approved and will be sent back to FTA for approval.

Buy/Sell Agreement – The committee is working on a section for the Model Legislation section of the Uniformity booklet.

2	Crosswalk (FTA and STCC Codes)	Committee reached out to the National Railroad Association to ask for assistance defining product codes and matching STCC to FTA codes. Cindy Anders-Robb was able to secure contact. Contact information will be forwarded to Lee Gonzalez and Ray Grimm. In addition, Cindy Anders-Robb will reach out to association and ask for contacts within each railroad company. Contacts will assist with defining products and matching codes. Ray Grimm asked for additional team members to assist with the project. Winston Stein volunteered to join the team. In addition, Rich Little will reach out to the IRS to find volunteers to assist with defining product types. Gene Holland also volunteered to join the team.	
3	2) Methods for Reporting Renewable Fuels	Ray Grimm submitted a survey to state and industry representatives. The survey requested feedback on the format of new product codes. Survey suggested the following options. Option 1 – 16 digit smart code. Option 2 – EIA Codes Option 3 - Hybrid of EIA code Option 4 – Other Ray received 7 responses. Due to limited feedback, survey was deemed non-representative of population (industry and state). A second survey was suggested that would ask each state to list the product types that are currently being used by each state. Survey will identify which product codes the team should focus on.	
4	Terminal Operator (Gross Gallons)	Survey will be created by Ray Grimm and forwarded to Lee Gonzalez. Team discussed the possibility of adding gross gallons to the schedule of receipts (terminal operator report). Survey was created by Lee Gonzalez that asked industry and states the benefits of adding gross gallons to the operator report. Lee received 10 responses to the survey. Summary of results include: 1) Some states currently require gross gallons on the schedule of receipts. 2) Current XML and EDI schema currently allow for gross gallons. 3) Industry (terminal operators) captures gross gallons. FTA MOTOR FUEL UNIFORMITY COMMITTEE COMMUNICATION & COORDINATION SUBCOMMITTEE PORTSMOUTH, VIRGINIA JANUARY 27, 2012

MINUTES

The Communication & Coordination Subcommittee met on Friday, January 27, 2012. State Co-Chair Christy Dixon and Industry Co-Chair, Deborah Compton conducted the meeting. The meeting was called to order at approximately 1:30 PM. There were 22 attendees present.

The minutes from the September 16, 2011 meeting were approved.

The latest edition of the Uniformer (January, 2012 copy) was distributed. The deadline for submission of articles to be in included in the January, 2012 Uniformer is May 15, 2012.

General

The subcommittee again recommended that someone from each region be the contact person again and send out the questionnaire to each of the states in their region and then send the responses back to Christy Dixon to compile all of the information so that it can be updated for the FTA Motor Fuel Annual Meeting in 2012. The information will be sent out to the states sometime in May, 2012.

The subcommittee was asked to do a definition for Liquefied Natural Gas (LNG). The subcommittee members were asked to submit their states' definition of LNG to Christy Dixon so that at the next meeting the committee can work on the definition.

There were no current definitions discussed at the meeting for any revisions.

Bill of Lading Project-Wilda Ice of West Virginia was not able to attend the meeting. This project has been tabled until June 1, 2012. Will try to get with Wilda and see what information she has compiled so that at the next meeting the subcommittee can decide what the next step is for this project. (White paper document, etc)

Cindy Anders-Robb reported that the MOU for the Motor Fuels Section for agencies that administer Motor Fuel that are not Revenue Agencies has been completed. The MOU will be sent out to be signed by the agencies that administer Motor Fuel Taxes that are not Revenue Agencies.

The project for draft language to be put in the Model Legislation Section for Buy-Sell Agreements and something for Renewable Fuels along with some type of diagram is tabled until the next meeting on June 1, 2012. Gene Holland with Conoco-Phillips is going to see what information he can find out about this project and let the subcommittee know.

A draft was presented by Edie Martin, Kansas, presented a draft of a white paper document to be put in the Uniformity Book about ExTole. The document explains what ExTole was and what the benefits and functionalities were. The white paper document was approved by the subcommittee members and then by the full Uniformity Committee.

Cindy Anders-Robb led a discussion concerning how the states are going to exchange import/export information since we no longer have ExTole. The states can send the information through their secure e-mail; however, this would require a password for each state. Cindy is going check about using the FTA's Website, Tax Exchange which is a secure section of the website and this way the state would only have to have 1 password instead of passwords for each state.

FTA MOTOR FUEL UNIFORMITY COMMITTEE COMPLIANCE SUB-COMMITTEE PORTSMOUTH, VA JANUARY 27, 2012

MINUTES

The Compliance Sub-Committee met on Friday, January 27, 2012. State Co-Chair Cindy Mongold conducted the meeting. The meeting began approximately 2:10 PM. There were 22 in attendance, which included 14 state representatives, 1 FTA, 1 IRS and 6 industry.

The minutes from the September 16, 2011 were approved with one change; Ray Rhodes was changed to Wayne Rhodes.

Training Schedule Update

On February 28, the instructors will get together to update the Basic and Advance classes.

The State of Minnesota has agreed to host the Basic training class this year and the Advanced class will be held in Savannah, GA at the DeSoto Hilton. Dates for the classes will be announced after February 28.

Dyed Fuel Stats

Jeremy Neeck of Minnesota reported that he'd had good response to his request for the states dyed fuel stats. He will be sending out reminders for the remaining responses. He's working on completing the 2011 report. Rich Little (IRS) has asked to be put on Jeremy's e-mail distribution of the report.

Jeremy and Doug Arndt (ND) have expanded the dyed fuel stat reporting sheet to include vehicle type and industry. Those additional items will be included in the 2012 stats.

A dyed fuel program was started in North Dakota. Minnesota dyed fuel inspectors trained the North Dakota inspectors. In 3 days plus one follow-up day there were approximately 24 violations identified.

Airport "Stale" Fuel Issues and Taxation

Concerns have been raised regarding the destination/taxing of stale fuel when removed from airports. It was determined that the issue/case that was identified at the last meeting was from several years ago. Additional research will be performed as a follow-up.

Sale of "Off Spec" Military Fuel

At a previous meeting it was reported that off spec fuel can be mixed with fresh fuel and if the product can be brought back to spec then it is used as originally intended. If restored back to spec then the fuel is used in generators or other non-critical equipment. It was suggested that Chris Postin (703) 767-5001 be contacted to obtain additional information on "off-spec" fuel at military bases.

Blender Pumps Blending of E85 with Gas to Dispense E10

Concerns have been discussed regarding the blending of E85 (lower tax rate) with gasoline at a blender pump to dispense E10 (higher tax rate). States are concerned about the tax gap in the two products. One state reported that E00 is being blended with gasoline to dispense the different %'s of gasohol. The IRS expresses concern with that, since E00 is not taxed by the federal government until it is blended.

Tax Laws on Fuel Used in Motorboats

Discussion regarding states laws on taxing fuel used in boats and refund laws. Virginia reported that the fuel was taxable however refundable to the end user.

New Projects for 2012?

Asked for suggestions for the Compliance Sub-Committee to work on in 2012.

Additional research will be done regarding current fuel tax evasion schemes.

Open Discussion

Discussion regarding taxing/fee on electric vehicles. North Carolina and Nebraska both reported that they have a fee on electric vehicles. A list serv question will be sent out asking if states either have existing laws or are introducing laws regarding taxing/fees on electric vehicles.

States were asked if they were doing any testing for sulfur content. States present were not aware of sulfur testing in their states.

A Midwestern state shared information with several other Midwestern states recently when they identified a fraudulent motor fuel refund request. The refund involved a mother and son providing fake SSN's and FEIN's along with fake receipts to support their request. It was reported that fraudulent claims were made in at least two additional states and one of the states has filed felony charges.

Also mentioned was a criminal case regarding phony documents for racing fuel.
